# Professional indemnity insurance arrangements

QBE and its representatives (including authorised representatives) are covered under professional indemnity insurance that complies with the requirements of section 912B of the *Corporations Act 2001* (Cth). The insurance (subject to terms and conditions) will continue to cover claims in relation to QBE's representatives/employees who no longer work for it (but who did at the time of the relevant conduct). #### Remuneration

The premium for this insurance policy is payable to QBE as the insurer.

Teachers Health Fund receives a commission from QBE, which is paid monthly. The commission for motor vehicle insurance is 5% of the total premium payable (excluding government charges) and for home building, contents and landlords insurance, it is 10% of the total premium payable (excluding government charges). The commission is paid to Teachers Health Fund by QBE for each policy issued or renewed. Teachers Health Fund may also receive a marketing allowance of up to 2% of the monthly gross written premiums paid. In addition to this, Teachers Health Fund may also be entitled to an incentive payment or profit share, .

Employees of Teachers Health Fund and QBE are paid an annual salary. Bonus payments or rewards may also be paid to QBE employees if certain sales targets are achieved. Bonuses are based upon sales targets for all of the activities of QBE staff, not only those related to financial services.

The above remuneration is included in the premium you pay,
