## Increased CPAP machine purchase benefit

# Physio – increased group therapy and new class therapy sub-limits

From 1 April 2017, we are increasing the group therapy sub-limit that exists under the overall physio limit to \$400. At the same time, we are also introducing a new limit of \$200 for class therapy which will form part of the group therapy sub-limit.

To help you understand the differences between class and group therapy, we have listed the definitions of the two below

**Class therapy:** The classed-based provision of a common intervention to a number of clients simultaneously which may be land or water based. A class participant must be individually assessed by a physiotherapist prior to participation.

**Group therapy:** A small group of clients are provided with different interventions concurrently which may be land or water based. Group interventions are characterised by the following features:

- pre-intervention assessment
- individually designed intervention provided and re-assessed during
- the consultation
- clinical record keeping.
