**TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Teachers Federation Health Ltd, also trading as Teachers Health / UniHealth, (ABN 86 097 030 414) of Level 4, Tower A, 260 Elizabeth Street, Sydney NSW 2000, telephone: 1300728 188.
